In cooperation with LifeBridge staff, participants initiate and coordinate recreational and educational activities at venues throughout the St. Louis metropolitan area and in virtual settings. Through these activities participants develop skills to navigate the community, socialize in a community-based setting, and self-advocate.

4b (Code: ) (Expenses \$ 187,529 including grants of \$ ) (Revenue \$ 116,543 ) LifeBridge Camps provide children and young adults an opportunity to become active participants rather than observers. Using adaptive equipment and techniques, children participate in a variety of sporting and recreational activities such as basketball, golf, dance, music and art therapy. Activities also include experiential learning activities such as a behind the scenes tour of the St. Louis Zoo or exploring a pirate ship. The organization offers day camp opportunities during the summer and during other school breaks or holidays.

4c (Code: ) (Expenses \$ 170,327 including grants of \$ ) (Revenue \$ 103,284 ) After School Services are enrichment programs offered through LifeBridge Leaders Club for students enrolled at St. Louis Public Schools' Nottingham CAJT campus and Promise Christian Academy. The primary goals of LifeBridge Leaders Club are to promote the development of soft skills for employment and for students to experience a sense of belonging. Students participate in two hours of activities including soft skills instruction and team building activities. The students also visit local venues to learn about job opportunities and practice soft skills with hiring managers.

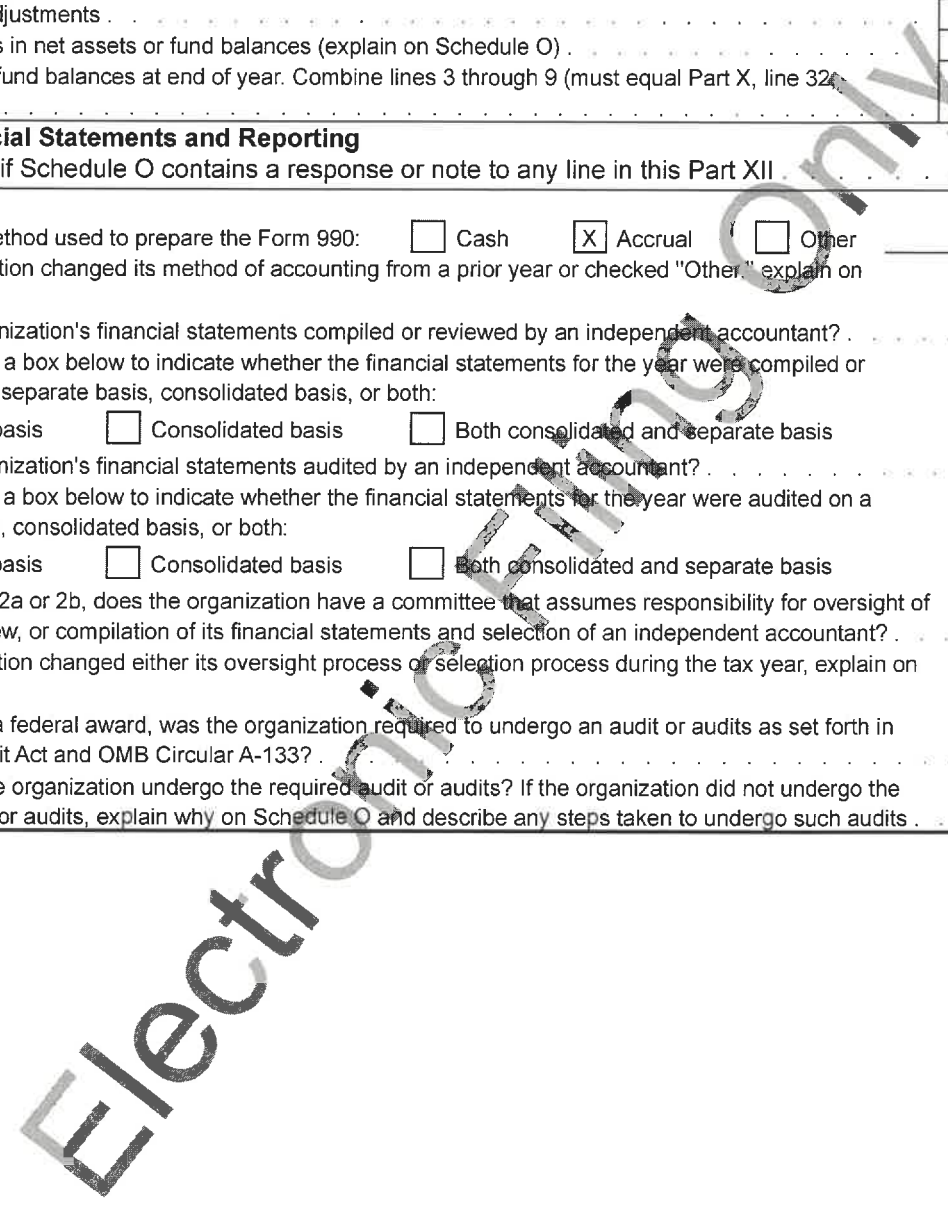
