Out and About Program - "Out and About" program provides support services to individuals with disabilities. These support services enable clients to explore the St Louis area, develop skills for independence, or maintain skills needed to be active in community life. Support services are provided in small group, recreational settings and include accessible door-to-door transportation. In planning and participating in activities, individuals work with staff and peers to form and cultivate relationships, explore the community, conduct monetary transactions, interact with other community members and learn how to navigate community venues. As a result, the individuals gain knowledge, experience and resources needed to actively and independently participate in community life.

**4b** (Code: ) (Expenses \$ 155,388 including grants of \$ ) (Revenue \$ 124,119 )  
LifeBridge Camps - This program provides four, week-long day camps for youth with disabilities. Clients participate in activities such as sports, art and music therapy, and community field trips. Clients may also experience special presentations through partnerships with groups such as first responders, aviation professionals or animal trainers. Accessible transportation is provided from centralized meeting points or, as needed, clients may utilize the agency's accessible, door-to-door transportation services.

SPARK Club - SPARK Club is an after school enrichment program for students who attend the Gateway School Complex in the St. Louis Public Schools. SPARK Club is held from 3pm to 5pm four days per week and serves up to 30 students. Program activities include adaptive sports, crafts and community field trips in addition to daily free-play that provides opportunities to practice socialization skills. Clients are provided accessible transportation home.
